AMENDMENT No. 03 TO THE CHARTER OF CREDIT BANK OF MOSCOW (open joint-stock company), CREDIT BANK OF MOSCOW, CREDIT INSTITUTION'S PRINCIPAL STATE REGISTRATION NUMBER 1027739555282, CREDIT INSTITUTION'S STATE REGISTRATION DATE: 18 NOVEMBER 2002, CREDIT INSTITUTION'S REGISTRATION NUMBER ASSIGNED TO IT BY THE BANK OF RUSSIA: 1978 OF 18 AUGUST 1999.

1. Clause 6.1, paragraph 1 of article 6 "CHARTER CAPITAL. PROPERTY OF THE BANK" shall be restated as follows:

"6.1. The Bank's charter capital shall be formed in the amount of 19,379,709,866 (nineteen billion three hundred seventy-nine million seven hundred nine thousand eight hundred and sixty-six) roubles and divided into 19,379,709,866 (nineteen billion three hundred seventy-nine million seven hundred nine thousand eight hundred and sixty-six) ordinary registered shares with a par value of 1 (one) rouble each."

2. Clause 7.3 of Article 7 "SHARES AND OTHER EMISSION SECURITIES OF THE BANK" shall be restated as follows:

"7.3. The number of ordinary registered shares of the Bank acquired by shareholders (placed shares) is 19,379,709,866 (nineteen billion three hundred seventy-nine million seven hundred nine thousand eight hundred sixty-six) of 1 (one) rouble par value each in a total of 19,379,709,866 (nineteen billion three hundred seventy-nine million seven hundred nine thousand eight hundred sixty-six) roubles."

3. Clause 7.4 of Article 7 "SHARES AND OTHER EMISSION SECURITIES OF THE BANK" shall be restated as follows:

"7.4. The number of authorised ordinary registered shares that may be placed by the Bank in addition to the placed shares is 16,896,448,142 (sixteen billion eight hundred ninety-six million four hundred forty-eight thousand one hundred and forty-two) of 1 (one) rouble par value each in a total of 16,896,448,142 (sixteen billion eight hundred ninety-six million four hundred forty-eight thousand one hundred and forty-two) roubles."

This amendment is made on the basis of the resolution of an extraordinary General Shareholders' Meeting, minutes No. 02 dated 25 May 2015, and an Extract dated 06.07.2015 from the register of credit institutions' securities issues (additional issues) registered by the Bank of Russia.
